## 2012 Enrolment time

In 2011 it was decided to change our enrolment forms to only completing the areas in green if supplied before. We received a number of forms returned to us with nothing completed not even the child's name.

Our enrolment form is a legal document and for this reason we have change our forms to must be completed in full even if you have provided the details before. No forms will be accepted if incomplete, this includes providing the CRN details. Any incomplete form will be returned and the days required will not be booked until the form is completed correctly.

Enrolment forms and hand book will be emailed to all families on Monday 31st October 2011. If you did not receive the email please advise staff. All places become available at the end of term 4 2011. All accounts must be finalised by the end of term 4. Any unpaid accounts will jeopardise your booking for 2012. If you have any concerns or queries please do not hesitate to speak with Julie or Cheryl.

**Behaviour:** We have recently reviewed our Behaviour and Discipline Policy and our Dismissal Policy. The centre has in place appropriate procedures for staff to follow when dealing with inappropriate behaviour. We would appreciate your support when dealing with inappropriate behaviour.

**Vacation Care:** Christmas vacation care will be open as follows. Please note the last day of the school term is Tuesday 20th December 2011. However we have been advised Monday 19th and Tuesday 20th December 2011 have been allocated as pupil free days. We will provide vacation care on these days including Wednesday 21st and Thursday 22nd December 2011 and re-open on Monday 9th January 2012. Vacation care forms will be available on 1st November 2011. The form must be completed in full and will not be accepted if incomplete. **The closing date for handing in your form is Friday 9th December 2011.** No forms will be accepted after this date nor will emails and phone calls booking in your child. **Out of School Activities:** Due to increased numbers at the centre it has been decided the out of school activities transport option has been cancelled. This is due to staff to children ratios. We apologise for any inconvenience.

**Arrival and Departure times:** Our centre is licensed to operate between the hours of 7—9am and 3—6 pm. Due to our licensing regulations we are unable to allow any child into the centre before 7.00am

Our centre closes at 6.00pm and we understand trains, traffic and situations do arise which may contribute to late pick ups. We would appreciate a phone call advising the situation and we request if possible you to organise someone to collect your child from the centre. A late fee will apply after 6.00pm if no call is received. A late fee will also apply to consistent late pick ups.

**Bookings:** Any extra days required please advise the centre. If we do not know your child is attending we will not know to collect your child. This also applies if your child will be absent for any reason, we need to know. Please communicate with the centre regarding Bookings.

We also request St Josephs families needing extra days to advise the centre. This will assist Julie when confirming the number of children she will be transporting.
